Sir,

The petitioner respectfully submits as under:-

The petitioner is bonafide resident of Village Hussainpur
Teh and Distt. SBS Nagar. It is worth ~~It worth~~ mentioning that father
of the petitioner Babu Ram migrated from Pakistan in the year 1947
during the partition of the country and since than the petitioner is
residing in the village Hussainpur Teh and Distt. Nawanshahr (SBS
Nagar).

2. That the petitioner us in actual, physical and cultivating
possession of the land and the petitioner made the land cultiviable
by levelling the same by spending lacs of rupees from his own
resources and even now the crops sown by petitioner are standing

in the suit land and for proper of irrigation the petitioner has installed two Engine Tube Well Bores and laid the underground Pipes and channelisation of water and the fact of possession is known to the entire family as well as the respondent.

3. That the respondent who is a clever person have got links with local revenue staff i.e. Patwari wrongly got his name entered in the Gudowaries whereas the respondent never cultivated the said land that and never remained in possession the said land as the respondent is not the resident of Village Hussainpur and is the resident of Village Sajawalpur. After the concealment of the fact the respondent applied to the Govt. for the allotment of the property and got the property allotted in his name by getting the wrong reports effected from the field staff and further by concealing the fact that he was the resident of some other village i.e. Sajawal Pur and not of Hussainpur in which the said land was situated and on wrong reports effected by the Patwari and Girdawar got wrong reports that the respondent is in occupation of property by concealing the fact of his being the resident of Vill. Sajawalpur and not of Hussainpur got the conveyance deed issued in his favour on 11-10-99

4. That conveyance deed dated 11-10-99 does not confer any right in favour of the respondent since it has been obtained by the respondent by concealing the true facts. The respondent never remained ^{cultivated} in possession of the property in question and it is the petitioner who is in possession ^{and is cultivating} of the property in question. It is only cleverness of respondent by which ^{it} the petitioner has been debarred grounds legal and valuable right. The conveyance deed issued by the department in favour of the respondent is liable to be set aside since it has been obtained by concealing the true facts.

5. That the respondent came to know about the fraudulent Act of the respdt since the respdt started threatening to dispossess the petitioner from the suit land claiming to be allottee of the said land on verification the petitioner came to know that the respdt has been able to get the property allotted in his name by concealment of facts and furnishing false information.

6. That the petitioner asked the respdt to get the conveyance deed cancelled which he had obtained by playing fraud on the State on which the respdt has been postponing the matter of transfer on one pretext or the other and now has flatly refused about 2 days back. Hence the present petition.

7. That requisite Court fee is affixed on the petition.

8. It is therefore prayed that the allotment in favour of the respondent by way of using the conveyance deed in his favour may be cancelled and may be allotted to petitioner in the interest of justice and respdt be prosecuted for concealment of facts and punishing false information.


